**BLUE BEAR® BEAN•e•doo® 780VC Vinyl Surface Cleaner** cleans old vinyl surfaces easily, making them look new again. Designed to remove dirt, grime and built-up oxidation, **BEAN•e•doo** is a safe, eco-friendly cleaner that can be used all year round.

**Application:** *Do not dilute with water.*

**For Small Areas:** Spray vinyl surface with **BEAN•e•doo** and lightly scrub with a scrub pad (Seals and gaskets must be chemical resistant). Let dwell for a few minutes, then rinse with water.

**For Large Areas:** Spray on with pump or airless sprayer. (Seals and gaskets must be chemical resistant.) Scrub surface as needed. Let sit for a few minutes. Rinse off with water.

**Clean Up:** Rinse clean with **BLUE BEAR® Emerge™ 700DG Degreaser**. Allow surface to dry before further preparations.

**Storage:** Keep container closed when not in use.

**Precautions:** Do not dilute **BEAN•e•doo**. Dispose of waste according to local regulations. Remember to properly dispose of rags to prevent the possibility of combustion. Used rags should always be stored in UL listed (or equivalent approved) covered containers. Avoid eye contact. Gloves are recommended for sensitive skin.

**Flash Point:** Above 425°F (218.33°C)

**pH Level:** 6.65 pH of 1/10 wt/wt solution in soft water
